The Corrections Committee seeks to carry the message to incarcerated alcoholics by bringing meetings and literature into facilities, raising awareness of the Corrections Correspondence Service (C.C.S.) among “inside” and “outside” A.A. members and helping individuals in custody transition to a local A.A. community through Prerelease Contacts.

The facilities Heart of Virginia (District 9) are currently involved with are:

Albemarle Charlottesville Regional Jail - ACRJ

Fluvanna Correctional Center for Women - FCCW

Blue Ridge Juvenile Detention Center – BRDC

Dillwyn Correctional Center - DCC

At the present time (January 2023) Dillwyn and FCCW are having in person meetings (men and women can attend). Other facilities are gearing up. Exciting time to get involved.

To volunteer for these facilities clearance and orientation are required. Each facility has its own requirements.

#### **For Inside and Outside AAs**

The CCS links AA members who are in custody with AA members on the outside so that both can share their experience, strength and hope with each other.

#### **Insider Request Form (F-73)**

This form is available to make it more accessible to corrections committee members who bring the A.A. message inside correctional facilities. The C.C.S. form is not intended for involuntary signups from a third-party individual. Our experience shows that unsolicited signing up for the C.C.S may delay a person's decision to turn to Alcoholics Anonymous for help. Instead, please have the “inside” A.A. complete the form and contact **Email:** [corrections@aa.org](mailto:corrections@aa.org) directly so that we can assist them in their C.C.S. request.

#### **Outside A.A. Members Only (CCS-3)**

The C.C.S. form is not intended for involuntary signups from a third-party individual.

There may be individual facility restrictions regarding this service – always good to check with your chairman.
